ANNOUNCEMENT FOR THE OPENING OF ONE RESEARCH GRANT (BI) - 1 Vacancy

Reference: 2024_092_BI_SponBIODIV

A competition is open for the attribution of 1 research grant (BI) in the framework of the project "SponBIODIV - Marine sponge biodiversity from genes to ecosystems: delivering knowledge and tools for sustainable management and conservation", funded in scope of the European Biodiversity Partnership (Biodiversa+) with reference **DivProtect/011/2021** within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported FCT, according to the following conditions:

- 1. Scientific area: Biological Sciences/Marine Sciences.
- **2.** Admission requirements: Any national, foreign or stateless candidate(s) who hold a master in the field of Biological Sciences with experience in marine sciences.

The applicants must have demonstrated experience in:

- taxonomy and systematics of the phylum Porifera
- optical and electron microscopy
- standard molecular biology techniques (DNA barcoding)
- phylogenetic analysis
- biodiversity data mining from public portals (e.g. GBIF, OBIS) and historical literature
- written and oral proficiency in English

The candidate should be enrolled in a PhD degree or be enrolled in a non-degree course integrated in the educational project of a higher education institution, developed in association or cooperation with one or several R&D units. If the applicant is not yet enrolled, it must meet the requirements to register; enrolment will be mandatory and proof necessary only at the moment of scholarship contracting.

Note: In the case of enrolment in courses that do not confer academic degree, the research grant can only be awarded to those who do not exceed, with the signing of the research grant contract in question, including possible renewals, an accumulated period of two years in this type of grant, consecutive or interpolated.

Conditions of preference: Experience in participating in projects related to benthic ecosystems characterization is highly advantageous.

Academic degrees awarded by a foreign higher education institution must comply with the provisions of Decree-Law no. 66/2018 of 16th August, which approves the legal regime of recognition of academic degrees and diplomas of Higher Education, attributed by foreign higher

education institutions, being any formalities established there in fulfilled only by the date of the contracting act.

- **3.** Work plan: The candidate will be responsible for supporting the work to be developed under "WP1 Biodiversity and biogeographic patterns", and "WP2 Phylodiversity", namely the development of a comprehensive dataset of sponge species and habitats distribution for the inference of basin-scale biodiversity and biogeographic patterns, as well as a DNA barcoding reference dataset. The candidate will also be supporting the analysis of the results and the writing of deliverable reports, as well as scientific papers.
- **4.** Legislation and official rules: Law nº.40/2004, 18th August (Research Fellowship Holder Statute) in its current version; Regulations for Studentships and Fellowships of the Fundação para a Ciência e a Tecnologia, I.P. and CIIMAR Grants Regulation.
- **5. Work place**: The work will be carried out in CIIMAR Interdisciplinary Centre of Marine and Environmental Research, Edifício do Terminal de Cruzeiros do Porto de Leixões, Av. General Norton de Matos, s/n, 4450-208 Matosinhos, in the Deep-Sea Biodiversity and Conservation Research Team, Portugal, under the supervision of the researcher Dr. Joana Xavier.
- **6. Duration of the contract:** Duration of 06 months, starting in February 2025, under the regime of exclusive dedication, eventually renewable up to 14 months.
- 7. Monthly stipend: The monthly maintenance allowance is 1259,64 € (one thousand two hundred and fifty nine euros and sixty four cents), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country: https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf. Payment will be made by bank transfer. In addition to this allowance, the grantee will be covered by a personal accident insurance.
- **8. Selection methods**: The ranking of candidates will be performed by a global evaluation (GE) of the *Curriculum vitae* and supporting documents performed according to the following criteria:

GE = [30%AQ+50%PE+20%MO]

- AQ: Academic qualification relevant for the scientific area, taking into account the University-level degrees, their appropriateness to the position as well as the performance of the candidate in each of such degrees), ranked from 0 to 10.
- PE: Professional experience in the field of study, ranked from 0 to 10.
- MO: Motivation of the candidate and interest in the field of research taking into account the motivation statement, ranked from 0 to 10.

The evaluation process may include an interview with the graders scored higher than 7 out of 10, which is intended to clarify aspects related to the results of their research, in which case the interview weighs 30% and the previous evaluation weighs 70%.

The selection will be based on the vote of each member of the jury regarding the most adequate candidate for the position, and, in the case of a tie in the vote, the vote of the president of the jury will prevail.

The jury reserves the right to not assign the research grant if none of the candidates meets all requirements and matches the desired profile.

9. Composition of the jury selection:

- **10.** Form of advertising/notification of results: The final results of the evaluation will be sent through a list sorting the candidates according to their attributed mark, by e-mail and available in CIIMAR website; in case of disagreement, the candidates have a 10-working day term in which to contest the decision, if it so wishes, as provided for in the *Código do Procedimento Administrativo* in a preliminary hearing setting. The jury reserves the right to not assign the contract depending on the quality of the applications.
- 11. Deadline for application and presentation of applications: The competition is open from 20-12-2024 until 06-01-2025. The applications must be formalized, compulsorily, by sending the following documents:
 - detailed Curriculum vitae;
 - copy of the eligibility certificates;
 - motivation letter, outlining past research activities and their relevance to the position;
 - contact information of two researchers familiar with the candidate's skills and competences;
 - any other documents that the candidates may recognize as relevant.

The whole application should be no larger than 20 MB. Applications that do not include all the previously indicated elements will not be considered. All candidates who formalise their applications in an improper way or fail to prove the admission requirements imposed by this tender are excluded from admission. In case of doubt, the panel is entitled to request any candidate to present further documentation supporting their statements.

12.
